***In order to participate as a member of the LAKELAX Lacrosse WINTER SESSION, (hereinafter collectively referred to as "LAKELAX TEAM"), each participant must submit completed versions of this Assumption of Risk, Wavier of Liability and Parental Permission Form and the accompanying Health Form. Participants who have not completed both forms will not be permitted to participate in team activities until they are received.***

**AGREEMENT TO PARTICIPATE**

To ensure that you and your parents understand and accept the risks of participation as a member of the LAKELAX Team, you both must indicate your understanding and agreement by signing on the appropriate lines below.

**CAMPER AGREEMENT**

I affirm that my participation as a member of the LAKELAX Team is entirely voluntary, and understand that participation on the LAKELAX Team involves a risk of injury due to certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries, such as, but not limited to, the following: contact with other individuals playing in the game; contact with the ground/floor, walls, goals, posts or equipment which are part of the playing area; and strenuous exertions, quick movements, and changes of speed, which place stress on the cardiovascular, muscular, and skeletal systems. The specific risks vary from (1) minor injuries such as scratches, bruises and sprains, to (2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions, to (3) catastrophic injuries including paralysis and death. I understand that if I have questions about possible hazards, it is my responsibility to seek additional information from the internet or the LAKELAX Team staff prior to signing this Form. I also understand that, despite safety precautions, the LAKELAX Team staff cannot guarantee that I will not be injured. I agree to assume these risks.

I understand that the best way to make sure that I remain safe and avoid injury is to follow the rules, regulations and instructions of the staff of the LAKELAX Team. I agree that I will learn and obey all the rules and regulations and will follow all instructions of the staff of the LAKELAX Team.

**PARENT/GUARDIAN AGREEMENT**

I agree to allow my child/ward to participate as a member of the LAKELAX Team and affirm that my child's/ward's participation is completely voluntary. I understand that there are risks inherent in the activities my child will engage in as a member of the LAKELAX Team (some of which are described above) which may cause serious injury or even death. I also understand that, despite safety precautions, the LAEKLAX Team staff cannot guarantee that my child/ward will not be injured. My child/ward and I are willing to assume these risks. To minimize the risk, I have instructed my child/ward to obey all the rules, regulations and instructions of the LAKELAX Team.

**ASSUMPTION OF RISK, WAIVER OF LIABILITY, RELEASE & AGREEMENT NOT TO SUE:** In consideration for permitting me/my child/ward to participate in the LAKELAX Camp, **I voluntarily agree**, for myself, my heirs, executors, and administrators, to the following:

**TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, OR PERSONAL INJURY**, including death that may be sustained by me/my child/ward, or any loss or damage to property owned by me/my child/ward, as a result of training for, participating in, or traveling to or from practices, tournaments and/or games as a member of the LAKELAX Team.

1. **TO RELEASE, WAIVE, REMISE, HOLD HARMLESS & DISCHARGE** the LAKELAX Team and its members, officers, principals, employees, agents, volunteers, coaches, staff, and any person or entity responsible for administering the LAKELAX Team, (hereinafter collectively referred to as "releasees") from any and all liability, claims, actions, demands, expenses, attorney's fees, breach of contract actions, breach of statutory duty, or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might now have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while training for, traveling to or from practices, tournaments/ or games, or participating as a member of the LAKELAX Team including, but not limited to, any claim that the act or omission complained of was caused in whole or in part by the negligence or carelessness of the releasees.

**MEDICAL EVALUATION:** I understand that I must submit a completed Health Form. I understand that I should obtain health insurance coverage prior to participating as a member of the LAKELAX Team. I further understand that I will be responsible for my medical expenses.
